

AMATEUR ATHLETIC RELEASE OF LIABILITY,
ASSUMPTION OF RISK, INDEMNIFICATION, COVENANT NOT TO SUE,
AND PERSONAL APPEARANCE AGREEMENT



PLEASE READ BEFORE SIGNING

In consideration of being allowed to participate in any way in **Boneshaker Project's** athletic sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,

3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS **Boneshaker Project Inc.**, its directors, officers, employees, independent contractors, agents, volunteers, partners, sponsors, advertisers, other program participants and if applicable, the owners, landlords and tenants of any premises used to conduct any class or event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE ORDINARY OR GROSS NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I further agree that under no circumstances will I, my heirs, assigns, personal representatives or next of kin sue Releasees or bring any claim or demand whatsoever, including but not limited to claims for personal injury, property damage, or death, based upon any matter released above, including any matter based upon Releasees' ordinary and/or gross acts or omissions.
